2023 Member and Affiliate Profile

Overall Counts

ASHA currently represents 234,244 members and affiliates: audiologists; speech-language pathologists (SLPs); speech, language, and hearing scientists; audiology and speech-language pathology assistants; and undergraduate, graduate, and doctoral students in communication sciences and disorders (CSD) who are members of the National Student Speech Language Hearing Association (NSSLHA). ASHA's membership and affiliation grew by 5,876 people in 2023—a 2.6% increase from the previous year.

Counts by Certification, Membership, and Affiliation Status

- Audiologists, SLPs, and Speech, Language, and Hearing Scientists. Excluding assistants and National NSSLHA members, ASHA represents 223,057 CSD professionals—up from 217,135 at year-end 2022 (a 2.7% increase).
- Certified Audiologists. ASHA represents 14,059 audiologists—up slightly from 14,029 at year-end 2022 (a 0.2% increase). Most (93.6%) audiologists are certified members.
- Certified Speech-Language Pathologists. ASHA represents 206,126 SLPs—up from 199,942 at year-end 2022 (a 3.1% increase). Most (98.4%) SLPs are certified members.
- Individuals With Dual Certification. ASHA represents 645 individuals who hold certification in both audiology and speech-language pathology—down from 683 at year-end 2022 (a 5.6% decline). Individuals with dual certification are counted separately from individuals certified in audiology or speech-language pathology only.
- Individuals With Certification in Process. The number of individuals who have started—but not yet completed—the certification process is 1,747—down from 1,855 at year-end 2022 (a 5.8% decline).
- Members Only. Only 393 ASHA members do not hold certification—down slightly from 399 at year-end 2022 (a 1.5% decrease).
- International Affiliates. ASHA represents 575 CSD professionals from 67 countries outside the United States—compared to 610 professionals from 63 countries at year-end 2022 (a 5.7% decrease).
- Certified Assistants. ASHA represents 881 assistants—up significantly from 672 at year-end 2022 (a 31.1% increase). Of these, 44 are certified in audiology, 786 are certified in speech-language pathology, and 51 have started—but not yet completed—the Assistants Certification Program.
- National NSSLHA Members. ASHA represents 10,306 students who are members of National NSSLHA—down slightly from 10,482 at year-end 2022 (a 1.7% decrease).

Demographics

- **Gender.** Overall, most (95.6%) ASHA members and affiliates self-identify as female—virtually unchanged from 95.7% at year-end 2022. About 12.4% of audiologists, 3.5% of SLPs, and 16.1% of those with dual certification self-identify as male.
- Race and Ethnicity. About 9.5% of ASHA members and affiliates self-identify as racially minoritized groups.
 Additionally, 7.0% of ASHA members and affiliates self-identify as Hispanic, Latina, Latino, Latinx, or as being of Spanish origin. In contrast, 38.4% of the U.S. population self-identify as racially minoritized groups; 18.7% self-identify as Hispanic or Latino (U.S. Census Bureau, 2020).
- Age. ASHA members and affiliates who are age 34 and younger (27.2%) and age 35–44 (28.7%) make up over half of the Association, followed by those who are age 45–54 (22.8%), 55–64 (12.8%), and 65 and older (8.4%).
- **Disability.** About 2.4% (5,466) of ASHA members and affiliates self-identify as having a disability. Of these, 1.2% (2,712) self-identify as having a speech-language disability, 0.7% (1,522) a mental or emotional disability, 0.4% (984) an auditory disability, 0.3% (746) a motor-mobility disability, and 0.1% (309) a visual disability.

Employment Characteristics

- Employment Status. Overall, most (74.8%) ASHA members and affiliates work full time; 16.0% work part time. Only 1.2% are unemployed and seeking work.
- Primary Employment Facility—Audiologists. Most (75.4%) audiologists work in health care settings, including
 hospitals and residential and nonresidential health care facilities. Most of the remainder work in either schools
 (7.1%) or colleges/universities (6.2%).
- Primary Employment Facility—SLPs. About half (49.9%) of SLPs work in schools. Most of the remainder (40.4%)
 work in either health care settings, including hospitals and residential and nonresidential health care facilities, or
 colleges/universities (2.4%).
- Private Practice. About 31.8% of audiologists and 23.5% of SLPs work full or part time in private practice.
- Primary Employment Function. About 78.1% of audiologists and 75.7% of SLPs are clinical service providers.
 Most of the remainder are special education teachers, college/university professors, researchers, administrators, or consultants.
