

STATE AUDIOLOGY LICENSURE LAWS & REGULATIONS FOR PRESCRIPTION (Rx) AND OVER THE COUNTER (OTC) HEARING AIDS

The information below is collected from state statutes, regulations, state licensure boards, and departments responsible for regulating the audiology profession, including hearing aid prescribing. This information is presented to guide members on state laws and regulations that may affect their practice. Notes:

- 1) The information below applies to licensed audiologists and excludes regulations that apply only to hearing aid dispensers/specialists.
- 2) FDA guidance on its OTC rule can be found at FDA Clarification Letter on the Impact of OTC Hearing Aid Rule on States (asha.org).
- 3) Under Federal law, states cannot require a physician referral or medical/audiological evaluations for OTC hearing aids. The categories of regulation listed below for physician referral and mandated procedures/equipment apply only to prescription (traditional) hearing aids.
