ASHA COVID-19 Survey Results - October 2020

Introduction

A survey was fielded on October 15, 2020 to all ASHA members and affiliates (*n* = 211,000; ASHA-certified members, noncertified members, individuals in process of applying for certification, certified nonmembers, Clinical Fellows, international affiliates, associates/assistants, and NSSLHA members) via an email blast. The purpose of the survey was to continue to track the pandemic's impact on members and to understand how ASHA could best help address member needs during the pandemic. A second email blast was sent on October 29. The survey closed at midnight on November 5. A total of 18,909 responses were received for an approximate response rate of 9.0%.

Results to the quantitative questions follow. Qualitative (open-ended) responses are unpublished due to the volume of them.
